SECTION I. Address the following items in order for Henrico Police to endorse this plan:

Provide new plans with details to address items noted below.

Provide a response addressing the items and/or stating the intent of the applicant.

Lighting:

- Some of the light poles around the parking areas are in conflict with adjacent trees. Please try to reduce the conflict so light can spread.
- Provide a light pole that is on a timer for the basketball court. •

Fencing:

Provide a fence around the basketball court and pool so access is not granted to the general • public. Provide access control measures like an RFID reader or keyed lock for the gates to these spaces. Provide specifications.

Building Access:

Henrico Police will need access to the apartment building when responding to calls for service. • How will HPD access the apartment's primary doors? HPD does not have access to Knox boxes so individual access will be needed. Consider providing a keypad for Police response. After construction, provide training for HPD so we can become acquainted with the access process.

The Henrico Police Division supports and implements Crime Prevention Through Environmental Design (CPTED), which is the theory that the proper design and effective use of the built environment can lead to a reduction in the incidence and fear of crime and an improvement in the quality of life.

The following characteristics need to be in place at this site.

- 1. **Natural Surveillance**. Provide natural surveillance throughout the site, especially to parking areas, buildings, building entrances, walkways, etc. Natural surveillance is the placement of physical features, activities and people in such a way as to maximize visibility.
- 2. **Natural Access Control**. Provide natural access control throughout the site. Natural access control is the physical guidance of people coming and going from a space by the judicial placement of entrances, exits, fencing, landscaping and lighting. The goal is to guide people where you want them to go and how you want them to get there.
- 3. **Territorial reinforcement**. Territorial reinforcement is the use of physical attributes that express ownership, such as fences, pavement treatments, art, signage and landscaping. The goal is to promote ownership and pride in where you live and work.
- 4. *Maintenance.* Allows for the continued use of space for its intended purpose. It also serves as an additional expression of ownership.

While our requirements for the endorsement of the plan do not guarantee a crime-free environment, it is our experience that the application of the concepts of Crime Prevention Through Environmental Design (CPTED) will reduce the opportunity for crime to occur and will enhance the quality of life.
