Sir/Madame:

The Planning Department has completed its review of the above-referenced Original Plan, received August 18, 2023, and has the following comments:

- Planning Department Comments The following Planning comments must be addressed prior to final approval of construction plans:
 - 1. Include case no. POD2023-00188 vertically in the upper right-hand corner of all plan sheets so that the case number can be read when the plans are rolled up.
 - 2. On the Cover Sheet:
 - a. Amend title to read, "Innsbrook North End Public Roadway, Streetscape and Lighting Plans."
 - b. Under Site Data, No. 1, include owner name and contact info for Northland Associates and River City Petroleum.
 - c. Under Site Data, include total area (i.e. square footage) of improvements associated with this submission. Include area within existing right-of-way and proposed right-of-way.
 - 3. On the E&S Control Plan, Phase I, Sheets R6.01-6.04:
 - a. Provide tree protection fencing around trees along Lake Brook Drive which will be preserved for future streetscape. Include a tree protection detail which illustrates type and height of fencing. Amend sequence of construction to state tree protection measures will be installed before pre-construction meeting.
 - b. If a temporary construction trailer will be utilized, graphically show and label location. If trailers are not shown on the construction plans, Sec. 24-4510 requires approval of a Temporary Use Permit by the Board of Zoning Appeals (BZA) prior to placement of a trailer onsite.
 - 4. On the Landscape, Lighting, Streetscape and Pedestrian Connection Plan, Sheets L1.01-2.10:
 - a. Include the photometric plan within the streetscape plan.

- b. Provide average footcandles to illustrate required average of 0.5 to 1.5 footcandles for streetscapes.
- c. Include pole mounting details for all fixture types proposed and dimension light fixture heights.
- d. Include a note stating all light fixtures are full cut-off and zero tilt fixture types.
- 5. See additional comments from other review agencies.
